WHAT IS THE PURPOSE OF THE FOUNDATION OF LAGUNA WOODS VILLAGE?

The Foundation of Laguna Woods Village is a non-profit charitable organization, formed in 1997, to give support services to residents of Laguna Woods Village who are in need. It is dedicated to assisting residents in maintaining their quality of life by providing temporary emergency assistance.

HOW DOES THE FOUNDATION OF LAGUNA WOODS VILLAGE HELP RESIDENTS?

The Foundation provides help on a case-by-case basis. The help includes: medications, utility bills, food shortages, medical and nursing care, caregivers and respite care, taxi vouchers, Meals-On-Wheels, Adult Day Care and Senior Center Congregate Meals.

HOW DOES THE FOUNDATION OF LAGUNA WOODS VILLAGE DETERMINE WHO NEEDS HELP?

Resident requests for assistance are processed by the Social Services Department and submitted to the Foundation Board for review after all sources of assistance have been exhausted.

All requests are given case numbers by the Social Services Department. Therefore, the resident's identities are kept confidential and all payments are made directly to the service providers.

WHO MANAGES THE FOUNDATION OF LAGUNA WOODS VILLAGE?

The Foundation Board of Directors is made up of Village residents who give their time and energy to our community without remuneration of any kind. The Board meets monthly to discuss the how, who, when and where to use the funds you so generously give to the Foundation to help your neighbors.



WHAT DOES IT COST TO OPERATE THE FOUNDATION?

Because the Foundation is operated by volunteers, more than 91 cents of every dollar you give goes to benefit village residents.

ARE GIFTS TO THE FOUNDATION TAX DEDUCTIBLE?

Yes. The Foundation of Laguna Woods Village is a 501 (c) (3), independent, non-profit, charitable organization. All donations are tax deductible to the extent of the law. Tax ID # 330757151.

HOW CAN I HELP?

Gifts of cash or a check can be sent to our address or deposited in a box across from our office on the first floor of the Community Center.

Donations may be made in remembrance of a deceased friend or loved one. The family of the deceased will receive a note from the Foundation recognizing your gift in sympathy with their loss.
